1. Commencement of Participation

2.2. No refund of the course fee will be awarded for any absence on any grounds, including medical or otherwise.

2.3. Participation in this course is not to be construed as talent scouting or auditioning for acting opportunities in Avant Theatre & Language. You are not to approach the company or its partners with intentions or negotiations for casting calls either directly or indirectly unless otherwise approached or offered by us or our partners.

3. Code of Conduct & Confidentiality

3.1. You shall conduct yourself professionally during your participation in the course. This includes punctuality, appropriate dressing and behaviour during the conduct of our activities.

3.2. You must keep us advised as to where you may be reached by telephone without unreasonable delay. You are also to inform us of any change in your particulars and contact information immediately.

3.3. You shall not during the continuance of your participation or after its termination disclose, divulge, impart or reveal to any individual or organization any of the trade secrets or confidential operations, processes, dealings or any information concerning the business affairs or transactions of the company and its partners. You shall not use or attempt to use any such information in any manner that is injurious or detrimental to the interests of the company and its partners.

3.4. The teaching materials and techniques provided during the course are to remain the property of the company at all times. You may not use these materials for any other purpose of teaching nor are you permitted to show or advice in any way of their details unless instructed by the company to do so.
